- ✓ If the article is sent through Portal de Revistas de la Universidad de Costa Rica, this document should be attached. (Step 4 of sending)
- ✓ This form should be addressed to the direct of the magazine Mag. Carolina Mora Chinchilla

## Important

- Sending the Letter of acceptance of copyright is necessary for postulation of the articles that are received by the magazine. Without this document the article wont go through to the editing process.
- Sending the letter of acceptance of copyright does not guarantee the publication of the article.
- In case the article is reject the author is informed and its copyright returned so that he can do what he considers.
- Revisa estudios is a non profit publication, nothing is charged for the publication
  of the articles nor are these sold. The author or the authors preserve moral rights
  over the publication and yield their patrimonial rights when they sign the letter
  of acceptance of copyright. Once published the articles can be diffused freely due
  to the politic of open access this publication follows as long as the origin and
  authorship are mentioned.

- Accept that the postulation and possible publication of the article in Revista Estudios will be governed by the editorial policies of the prior, the institutional normative of the University of Costa Rica and the legislation of the Republic of Costa Rica. Additionally, in any case of difference in criteria or future dispute, this will be resolved by the mechanisms of Alternative Resolution of Conflicts and the Costa rican Jurisdiction.
- 2. The work is original and unpublished, it constitutes an intelectual producción owned by the people indicated as authors and has not been published in print or digital format.
- The work has not been simultaneously postulated for publication to any other printed magazine, electronic or in any other written media or editorial organism. Documents that have been previously published in blogs, repositories of websites will not be accepted.
- 4. The work does not present any type of interest conflicts that can influence the results of the work and if it does it should be clearly stated in the work.
- 5. If the article has various authors and its impossible to credit any of them for a particular participation in the article the work will be considered colectiva and the authors will have to designate someone in charge of answering observations and queries from Revista Estudios and in case the article is published, to receive the correspondence of the readers.

- 6. Recognise that Revista Estudios does not necessarily share the affirmations that are exposed in the published document.
- 7. Declare that all the cited data within the work and its respective bibliographic references have in the document their correspondent credits and sources. Always using APA citation.
- 8. In the case the article contains tables, figures, illustrations, maps, photographs or similar; or any other copyright from a third party without permission as author o co author of the article then the authors will need to have the respective permission for the publication of these contents in Revista Estudios. When the author is informed the the manuscript has completed successfully the editorial process and has been approved for publication, he is responsible of facilitating the ORCID ID that can be generated through https://orcid.org.
